**48.01 FOOD VENDOR.** No person shall provide or sell food/beverages to the public in Cascade on July 28, 2007, from a temporary stand unless the person has first obtained a Vendor's Permit for the City of Cascade through the Cascade Community RAGBRAI Committee.

**48.02 FOR-PROFIT FOOD VENDOR FEES.** The fee for a For-Profit Food Vendor's Permit shall be \$500 with an application deadline date of June 26, 2007. The Cascade Community RAGBRAI Committee must approve all For-Profit Food Vendor permit applications. All For-Profit Food Vendors shall locate their food stand at the location to be determined by the Cascade Community RAGBRAI Committee. All For-Profit Food Vendors shall provide proof of liability insurance in an amount to be approved by the Cascade Community RAGBRAI Committee. All For-Profit Food Vendors shall comply with the Iowa Department of Health Rules and Regulations.

**48.03 LOCAL NON-PROFIT FOOD VENDOR FEES.** The fee for a Local Non-Profit Food Vendor permit shall be \$75.00, with an application deadline date of June 26, 2007. The Cascade Community RAGBRAI Committee must approve all Local Non-Profit Food Vendor permit applications. All Local Non-Profit Food Vendors shall locate their food stand at the location to be determined by the Cascade Community RAGBRAI Committee. All Local Non-Profit Food Vendors shall provide proof of liability insurance in an amount to be approved by the Cascade Community RAGBRAI Committee. All Local Non-Profit Food Vendors shall comply with the Iowa Department of Health Rules and Regulations.

**48.035 LOCAL FOR-PROFIT FOOD/STREET VENDORS.** The fee for a Local For-Profit Food/Street Vendor permit shall be \$150.00, with the application for all permits set at July 23, 2007. The Cascade Community RAGBRAI Committee must approve all Local For-Profit Food/Street Vendor permit applications. All Local For-Profit Food/Street Vendors shall comply with all local and state laws, including the Iowa Department of Health Rules and Regulations.

**48.04 STREET VENDOR.** No person shall provide or sell merchandise to the public in Cascade, Iowa on July 28, 2007, from a temporary stand unless the

person has first obtained a Vendor's Permit from the City of Cascade through the Cascade Community RAGBRAI Committee.

**48.05 STREET VENDOR FEES.** The fee for a Street Vendor permit shall be \$250.00, with an application deadline of June 26, 2007. All Street Vendors must locate their merchandise stand at a location to be determined by the Cascade Community RAGBRAI Committee. All Street Vendors shall provide proof of liability insurance in an amount to be approved by the Cascade Community RAGBRAI Committee. All Street Vendors shall comply with the Iowa Department of Revenue Rules and Regulations.

**48.06 NUISANCE.** The sale of food, beverages, merchandise, or entertainment from a temporary stand without a permit or locating a temporary stand at a location not approved by the Cascade Community RAGBRAI Committee on July 28, 2007, is hereby declared a nuisance. The police are hereby empowered to cause any offending temporary stand or outdoor entertainment location to be dismantled and removed without notice.

**48.07 EFFECTIVE DATE.** This ordinance shall take effect immediately upon publication as provided by law.

**48.08 EXCEPTIONS.** The provisions of this ordinance shall not apply to Cascade Farmers Market vendors located at the Riverview Park.
